Individually referred to as "Party" and together referred to as "Parties"

WHEREAS, Indian Institute of Skill Development Private Limited (IISD) has been established with a primary objective to enhance skills of youth of India to meet the growing demand of modern industrialization in India. IISD is a trusted NSDC training partners and embrace a vision of starting today to be a part of changing face of tomorrow, to building a locally employable, nationally demanded and globally prepared skilled workforce.

Currently IISD is engaged with Himachal Pradesh Kaushal Vikas Nigam (herein after referred as "HPKVN") for the implementation of training program funded by Asian Development Bank(Herein after referred as "ADB") for imparting skill training in the BFSI, Electronics, IT-ITES, Beauty and Wellness, Apparel & Made ups sectors to 2000 Graduate youth of Himachal Pradesh(herein after referred as "ADB Project"). The objective of this program is to improve the employment potential of the students of the University of Himachal Pradesh with systematic training, certificates of competency, and placement assistance. The programs offered under this project are aligned to Qualification Packs (QP) and National Occupational Standards (NOS) developed by NSDC through Sector Skill Councils, so as to bridge the gap of industry requirement for suitable jobs. The skills provided during the training will be measured by facilitating employment to the students post achieving certification.

This MoU has been prepared with the objective that both the parties will work together under the said "ADB project" for the accomplishment of desired goals. For this purpose below mentioned are the terms and conditions, required to be followed by both the parties: -

1. Renting / Hiring of Classrooms and Labs

IISD is showing his willingness for hiring classrooms and Labs in the premise of SV COLLEGE on monthly rental basis in order to implement the ADB project.

SV COLLEGE will provide 2 classroom and 1 Lab for training of candidates. Each room will have the capacity of at least 50 candidates. Maintenance and cleanliness of the classroom and Lab is on the part of YSP Classes.

2. Employing required Trainers and Staff

IISD will employee his own Master Trainers/Vocational trainers for imparting the skill training under the ADB project. Appointment of trainers and other supporting staff in on the part of IISD. SV COLLEGE will only provide a project coordinator to IISD who will look after the operations in the said premise.

3. Tenure of the Agreement

This agreement is valid for 12 months from the date of signing this agreement.

4. Financial Terms.

IISD agrees to pay following amount to SV COLLEGE on monthly basis.
