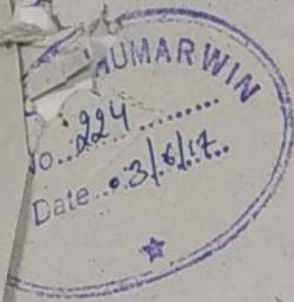



The other contents of the aforesaid Notification shall remain unchanged.





S. N.	Guidelines	Reporting of the Principal
1	P.G. in Science subjects should be run in the Colleges of District Head Quarters as per demand of the College concerned.	
2	College should have sufficient infrastructure and availability of posts as per UGC and H.P.U. guidelines. No additional posts shall be sanctioned for new course.	
3	College should have 10 years existence and total enrolment of the College concerned should not be less than 2000 in the three streams.	
4	College should be covered under 2F & 12(b) and NAAC accredited.	
5	Five years results of the College should be good i.e. better than the University pass %age in the subject.	
6	College should have good library with sufficient number of books, in the subject as per course requirement and for reference work, staff and internet facility.	
7	Availability of at least one staff (faculty) with Ph.D. in concerned subject.	
8	Availability of lab facilities commensurate with the requirement of a Post Graduate Course in Science subject.	
9	Enrolment in the U.G. classes in the concerned subjects in which P.G. classes are to be started.	

The above proposal may be supplied to this Directorate immediately so that the same could be sent to Government for approval.
