#### PRESS RELEASE

The Ministry of Minority Affairs (MoMA), Govt. of India has implements three Scholarship Schemes viz Pre-Matric, Post-Matric and Merit-cum-Means based Scholarship Schemes for the Minorities as Central Sector Schemes, with 100% Central funding. Under these Schemes, Scholarships are awarded to the Economically weaker and meritorious students from we centrally notified minority communities viz. Buddhist, Christian, Jain, Muslim, Sikh west pursuing studies in India in a Government or recognised private university /institute/college/school.

- During 2020-21, the online Implementation of the Pre-Matrie. Post-Matrie and Merit-eum-Means based Scholarship Schemes shall be done through the National Scholarship Portal (NSP) of the Government of India, under URL www.scholarships.gov.in. A Mobile App- National Scholarships (NSP) has also been prepared for the same for use by all applicants in the remote/hilly areas. A link to the site is also made available in the website of Ministry of Minority i.e. www.minorityaffairs.gov.in. Only Online Applications under the Schemes will be accepted and no request for offline applications will be entertained. The detailed guidelines of the three Scholarship Schemes and Asked Question (FAQs) with the timelines is available on the National Scholarship Portal (NSP) as well as on the website of this Ministry at URL- http://www.minorityaffairs.gov.in/en/schemesperformance/scholarship-schemes.
- 3. The Central Government has decided to open the National Scholarship Portal (NSP) on 16<sup>th</sup> August, 2020 for the three Scholarships Schemes for 2020-21. Other timelines are as under:-

- 4. The State-wise/Community-wise physical allocation for Fresh Scholarship for the financial year 2020-21 m respect of Pre-Matric, Post-Matric and Merit-cum-Mean based scholarship shall be is 30 lakh, 5 lakh and 60,000 scholarships respectively. As far as renewal applications are concerned, there is no target for them and all renewal applications are eligible for scholarship.
- The following changes have been made on NSP during 2020-21:
- The option for filling fee details (Admission Fee, Tuition Fee and Miscellaneous Fee) will not be provided to students during 2020-21. Instead, it must be filled by the Institutes. NSP team is making a provision for Institutes to enter course-wise fee (Admission Fee, Tuition Fee and Miscellaneous Fee) details in Institutions Profile section. During verification at Institute level, the fee in student application form will be auto populated using the details entered by Institutes in their profile. The Institutes can further edit the fee details for individual applications, based on various waivers given for the components to specific students.
- 6. It is, thus, incumbent upon this Ministry to initiate the process of inviting online applications through the State Government/UT Administration for the aforesaid Schemes, as per existing guidelines.
- 7. To increase publicity of the aforesaid three scholarship schemes for minority's efforts may also be made to place hoardings at District Collectorate Offices to promote the awareness for the minority students as well as Institution Registration on NSP portal, etc.
- 8. The Institutions which are not approved or registered on NSP Portal are directed to update the KYC registration. Also update the KYC, if the scholarship In-charge of the Institutions is changed. The Institutions which are already approved needs not to update the KYC and efforts to be made to increase the number of renewal applicants under Pre-Matric and Post Matric Scholarship Schemes and to ensure Aadhaar seeding/authentication of all online applications. The list of Institutes is also available in the District login under the option "Institute Registration KYC Form Status" from where School-wise list of Institutes along with their KYC status can be readily downloaded.
