Subject: - Extension of benefits of 'Retirement Gratuity and Death Gratuity' to the Himachal Pradesh Government employees covered by New Defined Contributory Pension Scheme (known as NPS).

The undersigned is directed to say that the pension of the State Government servants appointed on or after 15-5-2003 is regulated by the New Defined Contributory Pension Scheme (known as NPS) Notified by the State Government vide Notification No. Fin (Pen) A (3)-1/96, dated 17-08-2006 read with Notification No. Fin (Pen) A (3)1/96 dated 15-5-2003.

2. The issue for grant of gratuity to the Government servants covered by the New Pension Scheme has been under consideration of the Government. It has been decided that the Government employees covered under New Pension System shall be eligible for the benefit of retirement gratuity and death gratuity on the terms and conditions as are applicable to the employees covered under the CCS (Pension) Rules, 1972 subject to a maximum of 12/2 times of the emoluments (i.e. 25 years qualifying service).

3. The maximum limit of Retirement Gratuity and death gratuity shall be Rs.10-00 Lakh.

4. This order will be applicable to those Himachal Pradesh Government employees who joined service in Government Departments on regular basis on or after 15-5-2003 and are covered by the New Defined Contributory Pension Scheme (known as New Pension Scheme) Notified by the State Government vide Notification No. Fin (Pen) A (3)-1/96 dated 17-8-2006 read with Govt. Notification No. Fin (Pen) A (3)1/96dated 15-5-2003.

5. These orders shall take effect from the date of publication in the Rajpatra.
