

(3) Display advertisements for admission for further studies like Ph.D /Research, fellowships, scholarships for higher studies etc.

(4) Lecture/presentations from experts on career Guidance.

(5) Arrange visit to companies to make students aware about jobs.

(6) Make liaison with District /Block Employment exchange for employment purpose.
