# Hostel Rules adopted from Himachal Pradesh University Girls Hostel

## Swami Vivekanand Govt College Ghumarwin, Bilaspur. HP

All hostels will formally close on the day of the last regular examination. Each border will have to vacate his/her room within 72 hours of the termination of his/her regular examination. Fine per day or any disciplinary action, if required, will be taken for overstay.
Residents should not keep cash or jewellery or other valuables in their rooms. The responsibility for safety of their belongings will be entirely that of the residents.
Every resident shall be responsible for the safety of the furniture given to them. Furniture is not to be removed from one room to another. Damage to hostel property is a serious offense. Any boarder found guilty of damaging hostel property will be liable for disciplinary action as per hostel rules including expulsion from the hostel/College.
An undertaking on a prescribed proforma from the students and their parents will be obtained at the time of admission in the hostels to the effect that she will not participate in any political and indisciplinary activities which harms the social, academic and congenial environment of the Hostel/College.
Before leaving the hostel every resident shall obtain clearance from Warden and personally hand over the charge of the room and hostel property, repair charges for any damage to the furniture will have to be paid by the residents.
No student shall be allowed to accommodate any other student in her room. If it is found at any stage that a student other than the boarder is staying in her room, the hostel admission shall be canceled.
A student cannot shift the allotted room without the written permission of the Warden, that too at the end of academic session.
The residents will not move to other rooms for sleeping without the permission of
A resident shall under all circumstances, inform the Warden about her absence from the hostel. She shall sign the register maintained for the purpose at the hostel gate. The names of the residents absenting themselves without permission for a fortnight or more may be struck off the rolls and possession of their rooms taken by the Warden/Hostel Advisory Committee.

#### 28.5 CONDUCT AND DISCIPLINES ☐ Students shall maintain discipline and peaceful atmosphere in hostel ☐ A student may be fined or expelled from the hostel by the Chief Warden/ Warden/ Hostel Advisory Committee for the following reasons: a) Misbehaviour of any kind, which will include disrespectful conduct towards the Warden/ Hostel Advisory Committee or other teacher, employees of the hostel, Mess and other residents. b) Teasing or otherwise harassing other students and/ or the use of violence c) Stealing Hostel/ College property or the property of other students d) Writing on walls, sticking of posters, distribution of unauthorized handbills or notices e) Making noise and/ or creating other disturbance including the use of transistor, radio etc. in a manner likely to disturb other boarders f) Convening, organizing, attending unauthorized meetings within the hostel premises; and g) Breach of any of the hostel rules. ☐ While visiting common room/dining hall, the student should be in proper dress ☐ For any willful disobedience or defiance or willful tampering with hostel property or insolvent behavior, the student may asked by the Warden/ Hostel Advisory Committee to leave the hostel immediately in anticipation of the approval of the Principal. ☐ Students shall use or handle with care all property belonging to the hostel. When a student found guilty of want on damage of hostel property, the warden/ Hostel Advisory Committee may recover the cost of repair or replacement and in addition, may impose a fine or recommend imposition of fine depending on the circumstances ☐ In case of any unauthorized guest/ person is found in the rooms of the boarders, her room as well as the admission from the concerned department will liable to be cancelled forthwith. ☐ All rooms in the hostel shall be opened for inspection by Chief Warden/ Hostel Advisory Committee/ Warden/Attendent at any time during day and night ☐ The dealing of the students with fellow students should be courteous. Quarrels or

28.6 SPECIAL RULES (FOR GIRLS HOSTEL)
Regular roll call will be taken by the prefects of the Girls Hostel. The roll call time would usually be as under, which can be changed by the Warden from time to time, through notification.  Summer (May -September )7 pm  Winter (October - April) 6 pm  □ No girl student would stay out of the Hostel after the prescribed time  □ On Wednesday and Saturday, the girls can go to the city for shopping,they need to take written permission if they want to go out of Ghumarwin.  □ The girls who are going to local guardians or to their homes must write on the register kept for the purpose, the following details:-  a) The address where they are going  b) Time and date of their departure and arrivel
b) Time and date of their departure and arrival c) The relation.  The written request for the same must be communicated by the parents of residents with the above details in advance for confirmation.
<ul> <li>□ The guardians of the girls can meet their wards on every Monday and Friday between 1.00 pm to 3.00 pm. No one can meet the boarders in the hostel on other days except in case of emergency, with the prior permission of the Warden, in case they are coming from outside Bilaspur. The guardians need to show their identity card if demanded by the security guard or warden.</li> <li>□ No female guest can stay in any room without prior permission of the Warden</li> <li>□ No Male visitor is allowed in the rooms of the Girls Hostels</li> </ul>
<ul> <li>□ The girl residents are not allowed to stay overnight out of the hostel. In case there is such need, the Wardens prior permission in writing, must be obtained the address where one wants to stay and the purpose of stay must be given.</li> <li>□ Mutual shifting of girls boarders from one room to another room may is allowed only for one time at the end of the academic session with the growing in the state.</li> </ul>
<ul> <li>Students must use the washrooms properly (use incinerators /dustbins for proper disposal of sanitary pads, soap/shampoo covers, hair, hair-pins, etc).</li> <li>Students are not allowed to use mobile phones between 9 pm and 7am. (Except for study purposes. (engaging in phones and video calls in prescribed timing irrespective of study matter is strictly prohibited)</li> </ul>

For less than 15 days = half amount of the total mess amount of the month.\*

For more than 15 days = Full charges for the mess amount.

\* provided the candidate intimate the same to the mess contractor in writing prior to proceeding on leave.

Mess charges will be collected on every 5th and 6th of every month. For late payment, a fine per day for every mess bill separately will be imposed. After 25th a notice to pay the dues, will be served on the defaulter by the Hostel Welfare Officer/Warden. After 30th the room will be vacated with the order of the Principal.  Every resident must pay mess charges before going on summer or winter vacations.
There shall not be any Diet off/ Meal off option in general but under specific circumstances such as if a student is on medical leave (a certificate of the same must be produced duly certified from Govt. Medical officer); having an approved academic leave from the College; on study tour equal to or more than five days approved through respective HoD and Principal, provided the prior notice is given. Applications for diet off/Meal Off under these clauses shall be submitted through proper channels through warden and Principal.
Every off and on, Feedback shall be collected from the inmates by the Warden, Hostel Advisory Committee/ Principal to monitor the quality & service of the Mess by the vendor.
Any violation of regulation by both mess vendors & Inmates(students) may bring disciplinary/legal action. The Hostel Advisory Committee is authorized to take disciplinary/Legal action on both Mess Vendor & students in consultation with the Principal.
Hygiene of Cooked food, Dining area, Store Room shall not be compromised at any cost. If any one found guilty/responsible for an unhygienic situation prevailing in the mess area (Mess vendor, Student) serious financial penalty shall be imposed on them by the college management, subjected to the recommendation by the Hostel advisory committee.
Cleanliness & Hygiene of Kitchen, dining area is the responsibility of Mess Vendor.
Meals will not be served before/ after the fixed hours in the rooms, except in cases of illness, and that too only with the permission of the Warden/ Principal.
