

- a) Mobilization and Counselling of eligible and deserving candidates shall be the responsibility of Training Service Provider (TSP) and also use necessary tools for evaluation of the candidates before enrollment.
- b) Training Service Provider shall undertake focused awareness generation activities for mobilization of candidates which include display of posters/banners at prominent locations in the college campus, distribution of pamphlets, disseminating information about the programme its benefits.
- c) Candidates who qualify the counselling sessions shall be registered for training programme.
- d) The minimum batch size would be 20 and maximum batch size would be 30 candidates
