

M is the marks obtained by the candidate in the test paper mentioned on the GATE 2025 Score Card

M_3 is the qualifying marks for general category candidates in the test paper

M_1 is the mean of marks of top 0.1% or top 10 (whichever is larger) of all the candidates who appeared in the test paper

$S_4 = 350$, is the score assigned to M_3 and

$S_5 = 900$, is the score assigned to M_1

In the GATE 2025 score formula, the qualifying marks (M_3) for the general category candidate in each subject will be:

Out-off marks for GENERAL category = $\max(25, \min(40, \mu + \sigma))$. Here μ is the mean and σ is the standard deviation of positive marks of all the candidates who appeared in the test paper.




